Expedited Lost Pass Port Replacement - What To Do

Losing a vital document such as a passport can be a frustrating experience as it is an essential item legally required for traveling outside of the States. Should one experience the unfortunate circumstance of losing the item as a result of carelessness or theft, an expedited lost passport can assist in receiving the travel document in a rush. Specific legal procedure is required for obtaining a replacement document.

The Procedure

The procedure for a new document is dependent on the location of the passport holder in which the travel booklet has gone missing. Should one have upcoming travel plans or find themselves in a foreign country without the legally required document, expedition services can assist in a fast replacement. It is important to begin the replacement procedure as soon as you have noticed that the document has disappeared.

Reporting Loss

The first step in following legal procedure is to contact the United States State Department in reporting the document as missing. If a document has been stolen, a police report is often required to be completed, detailing the situation in which the individual was a victim of theft. In reporting the missing item to the State Department one is taking the necessary precaution in invalidating the document so that it is not used for illegal purposes.

Required Forms

Completion of a number of documents is required in order to receive a replacement passport book. These include the DS-64 form, which requires details surrounding the circumstance for the loss of the document. In submission with DS-64 is the standard application form for a renewal.

Expediting

Should one have plans for traveling in a few days to a week, expedition services can speed up the application process. Whether government or independent expeditors are used, extra charges will apply for the actual application forms as well as the additional services. An independent expeditor provides professional services for obtaining necessary documentation and submitting to authorities while avoiding long procedure.

Foreign Help

Every citizen of America can utilize the State expedition services where individuals who have traveled abroad should consult the closest Embassy or Consulate. Agents are professionals who are able to answer all questions related to applying for a new travel document. Always report the travel booklet as missing to the relevant authorities.

Required Documentation

The disappearance of the travel document within the States requires following procedures similar to those of a first time applicant. Upon submission, one must include the DS-64, DS-11 forms and necessary personal documentation. The additional documents include certified birth certificates, driver's licenses and photographs that are passport sized.

Expedition services should include placing the designated documents in a letter-sized envelope with expedite written on the front. It is best to select two-way overnight delivery including a letter of authorization if independent expedition services are used. For efficient processing of an [expedited lost United States pass port](#), ensure that all relevant documentation and if necessary a [U.S. passport application](#) is correctly completed.
