Qualifications To Become Immigrants

An aspiring immigrant will have to complete all the necessary requirements before she or he can gain entry to a country. Aspiring immigrants are needed to accomplish a medical report. They want to file a document with a sworn statement that they'll follow the country's law. An aspiring immigrant will instantly forfeit his or her application if one has no valid passport. The aspiring migrant must also have no criminal record or pending legal case. Most of all, that person has to complete all the necessary requirements given by the immigration agency of that country.

The Temporary Visa

Depending on their reasons to stay, an aspiring immigrant may be granted temporary residency. Immigrants with temporary visas has to abide the rules and agreement between them and the government, and when the residency expires, they have to leave the country. However, it is still possible to extend the residency.

One type of temporary residency is having a student visa. With the aid of immigration lawyers, students can study in the country for a specific period of time. Working permits will also grant temporary residency to immigrants. Immigrants with this status are those skilled workers. Migrant professionals working in the healthcare industry like caregivers are eligible for short-term residency.

The Permanent Visa

If an immigrant is given a permanent visa, she or he is allowed by the government to live in the country and have more legal rights. Unfortunately, permanent residency doesn't make them a naturalized citizen of the country. Obtaining a permanent visa can be done in many ways.

Permanent residency or visa can also be obtained if one is really a qualified and skilled worker. Since there are many skilled workers, aspiring immigrants has to pass all the necessary guidelines and requirements before they could get a permanent visa. It is important that they could show immigration agencies that they have enough money to start anew and support themselves. Age, language skills and educations are other factors that has to be considered before giving a permanent visa.
